Added contractual matrix proposal:

- addition of the element contractualMatrix inside the Documentation type.

- within contractualMatrix are the following elements:

- matrixType. A mandatory element to identify the form of applicable matrix. The list of valid values will be controlled through a Scheme identified through a default URI.

- publicationDate. An optional element of type date to specify the publication date of the applicable version of the matrix.

- matrixTerm. An optional element which defines any applicable "key" into the relevant matrix. For example, the Transaction Type would be the single term required for the Credit Derivatives Physical Settlement Matrix. Each term would have its own Scheme to control the list of possible values.
